Article 1

Article 7

The purpose for which this corporation is organized:

UA will also provide appropriate interventions and support by communicating and modeling high standards for behavior and academic achievement to students as they mature into young, college-going adults.

Article 8

The period of the duration of this corporation is perpetual.

Article 9

Limitation on Private Inurement: No part of the net earnings of this corporation shall inure to the benefit of, or be distributed to, its directors, officers, staff members or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

General Limitation on Nonprofit activities: Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code or(2) by a corporation contributions to which are deductible under Section 170© (2) of the Internal Revenue Code.

Article 10

Dissolution Clause

A formal vote of the Board of Trustees will be taken to decide upon dissolving the educational entity. A vote will be recorded in the minutes of the Board. The proper legal paperwork to dissolve the corporation will begin. Proper steps will be taken in accordance with Louisiana Law. All remaining assets will be used for charitable or educational purposes.


